By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Puppies under 4 months of age are prohibited from the show grounds.

All dogs must be on leash or confined except when being judged.
